Applicant shall submit the following documents as per corresponding sequence:

5. Requirements on administrative location map, land distribution map and land plan map:

3) Land plan map of each individual plot (in which shall show the shape, acreage, surroundings, setup of buffer zones, major landmarks and locations of rivers, wells and/or other water sources).

6. Environmental quality monitoring (testing) report or official data of the production site:

7. Trademarks (if applicable) 商标 (适用时)。

1) Applicants using other company's trademark(s), shall provide authorization/contract of trademark use and the trademark registration certificate(s).

2) Applicant using own trademark(s), shall provide the trademark registration certificate(s).

8. Organic production Quality Management System (QMS) (In which terms in 7.2.4 of GB/T 19630 shall be included)

9. Standard Operation Procedure (SOP) of organic production :

1) Technical specifications for each crop under application, shall include but not limited to the points below:

- e) Crop rotation plans and planting procedures/management for rotation crops (if applicable).

- 2) Specifications for preventing contamination of organic product by prohibited substances.

- 3) Control measure for preventing commingling of organic and conventional products (applicable if parallel production will be applied).
防止有机产品与非有机产品混杂所采取的措施 (存在平行生产的企业应提交)。
- 4) Specifications for crop harvesting and post-harvest activities including transportation, storage etc.

- 5) Specifications for maintenance and cleaning of transport vehicle, machinery, equipment, warehousing facility.

10. *Relevant documents of all inputs applied in the current year (shall be presented with signature of record-keeping personnel and company seal, its absence is acceptable if no operation and records occurred yet, however it shall be compulsorily presented during audit). Including documents as below:*

- 1) Harvest, storage and stock-out (if applicable) record of self-produced seeds.

- 2) Purchasing receipts, photocopy of package of outsourced seeds or seedlings, and certificate/attestation which proves outsourced seeds or seedlings are free of GMO and prohibited-substance treatment.

- 3) Raw material purchasing receipts, operation records for homemade compost.

- 4) Purchasing receipts, registration certificate and product Safety Data Sheet/specification/evaluation certificate/testing report shall be provided when organic fertilizer is outsourced.

- 5) Raw material purchasing receipts, operation records for homemade plant protection products.

- 6) Purchasing receipts, registration certificate and product Safety Data Sheet/specification shall be provided when plant protection substances are outsourced (include bio-pesticide, yellow sticky board).

- 7) Standing book records for all inputs (including seeds, seedlings, fertilizer and plant protection substance).

Product Processing 加工

(The documents as mentioned below shall be provided additionally if processing will be applied to harvests.)
(适用于收获后需进行加工的产品)

1. *Organic Product Certification Questionnaire (Organic Product Processing).*

2. *Copy of processing authorization/permission document (candidate products should be included).*

SC 证书副本及明细页复印件。 (明细页中品种明细一栏中需包括认证的产品种类)

3. *Requirements on administrative location map, plant plan map and equipment distribution map.*

加工厂行政位置图、厂区平面图及车间设备位置图。要求

1) Administrative location map (at scale of city, county or township) with mark for processing plant
加工厂行政位置图 (市、县或乡的行政图, 应标明加工厂所在的位置)。

2) Plant plan map (in which shall show the surrounding land-use, processing area, packing site and warehouse, etc.).

加工厂区平面图 (应标明加工厂周边环境、加工、包装车间、仓库等)。

3) Equipment distribution map (specify machinery for organic processing). 车间设备位置图 (应标明相关设备的分布情况)。
4. Processing water testing report (if applicable). 加工用水的检测报告 (适用时)。
5. Processing consignment contract (i.e. subcontracting) and copy of Business License shall be provided if applicable: 如为委托加工, 提供委托加工厂营业执照复印件和有机加工委托合同。要求: 1) Contract shall specify products, quantity and duration. 委托合同中应明确加工有机产品明细、数量、有效期限。 2) Contract shall also specify detailed requirement in reference to organic processing, e.g. Control measure for preventing commingling of organic and conventional products, and the other control measures. 应在委托合同中体现有机加工的具体要求, 包括防止有机产品与非有机产品混杂所采取的措施等。
6. For additional warehouse which is rented from the third-party, lease contract, administrative location map and plan map shall be provided. 若外租仓库, 应提供仓库的租用合同、行政位置图及平面图。
7. Organic product processing specifications: 有机产品加工规程。包括: 1) Process flow diagram with description operating steps for products. 产品加工技术规程。 2) Specifications on transport methods and storage for finished products. 加工产品的运输、贮藏等各道工序的操作规程。 3) Specifications for processing plant sanitation management and pest control. 加工厂卫生管理与有害生物控制规程。
8. Processing records in current year (shall be presented with signature of record-keeping personnel and company seal, its absence is acceptable if no operation and records occurred yet, however it shall be compulsorily presented during audit). 本年度加工环节相关记录 (应有记录人手签字或加盖公章, 如未发生, 可暂不提供, 待现场检查时提交至检查组)。包括: 1) Raw material stock in record. 原料的入库记录。 2) Records of processing. 加工过程记录。 3) Purchase receipts, product specifications and standing book records for food additives and processing aids. 食品添加剂、加工助剂的购买单据、产品说明书及台帐记录。 4) Package, labeling, storage, stock in and stock out record for finished products. 包装、标识、贮藏、出库、运输记录。 5) Sales record.

Note **注:**

- 1 The documents as mentioned above are required generally for the application for organic plant production and processing certification. During on-site inspection, the inspector may request the applicant to provide additional documents unmentioned herein according to the actual situation. 以上文件是对申请有机植物生产和加工认证的一般性要求, 在现场检查时检查员可能会针对生产的具体情况要求申请单位提供本清单未涉及的文件。
- 2 Regarding inapplicable or unavailable documents, a written explanation signed by the personnel in charge with the official seal affixed shall be submitted. 对于不适用或无法提供的文件, 应统一提交书面说明, 负责人签字并加盖公章确认。
